



New water service connections in private land




Service connections, our responsibilites and your responsibilites

In some cases our mains run across private land. When a new service connection is requested to a water main that is on private land, the roles and responsibilities for us and you vary dependant upon the position of the water mains. This guide covers the three most common scenarios where service connections are requested from mains in private land.

Main 18 metres from centre of highway



Our responsibilities

To service notice of entry on land owner.

To lay service pipe across public highway.

To lay service pipe from main to customer boundary including connecting to the water main.

To install water meter at point **A**.

To appoint land agent to establish land owner if not known.

To appoint land agent to agree compensation with land owner.

Your responsibilities

To lay service pipe from property to highway boundary.

Ensure service pipe meets the requirements of <u>Water Supply</u> (Water Fittings) Regulations 1999.


Water main in private land opposite side of highway


Your responsibilities

To lay service pipe from property to highway water main.

To agree entry to private land with owner, arrange easement and compensation.

To lay service pipe from main to public highway.

Establishing ownership of private land and compensation

Where we have to appoint a land agent to establish the private land owner and to negotiate compensation, the cost of the land agents time and compensation amount will be recovered from you. You will be required to pay a deposit based on the estimated costs before the work commences, and an invoice or refund will be issued once the actual costs of the work are known.

Chlorination of long service pipe

If the part of the service pipe installed by you is greater than 50 metres in length, the pipe will need to be tested and chlorinated. For pipes with a diameter greater than 50 metres, please contact our Connections Team for advice. Please refer to our 'disinfection, pressure testing, and commissioning of private supply pipes and mains' fact sheet.
