Implementing the plan

1. What are your views of these principles? When thinking about your answer, you may wish to consider how easy (or hard) you would find adopting the principles.

Anglian Water is the country's largest water supply and water recycling company, serving over 6 million customers in the east of England. The region we serve between the Humber and Thames estuaries encompasses a fifth of England's land area and has the lowest rainfall and some of the highest growth rates in the country. It also contains half of the country's Grade One agricultural land, and 1,500 kilometres of coastline, much of it eroding or exposed to significant flood risks. Therefore, we are acutely aware of the critical role we play in underpinning sustainable growth and increasing the resilience of our region to the impacts of climate change. We welcome the opportunity to contribute to the second cycle of draft River Basin Management Plans.

Anglian Water agrees that adopting these principles will help the water environment better prepare for climate impacts and deliver multiple benefits for people and nature. The implementation plan aligns with our purpose as a water company; to bring social and environmental prosperity to our region.

Anglian Water is pleased to see that the implementation plan encourages a collaborative, place-based approach, use evidence to make decisions, consider net zero targets and to work with natural processes. These approaches have been taken at our <u>wetlands at Ingoldisthorpe</u> for example, which we delivered in partnership with Norfolk Rivers Trust. At Anglian, we take account of the future risks to delivery – in particular, the effects of climate change and population growth to make sure actions perform as intended over their lifetime – which is outlined in the RBMP implementation plan. We also contribute to net zero and have our own internal road map to net zero by 2030. The net zero target will cover all the company's operational activities and those of its supply chain as well as a commitment to cut capital carbon by 70 per cent against a 2010 baseline.

Innovation is at the heart of everything we do at Anglian. We would therefore suggest adding a principle to encourage innovative solutions and risk-sharing to drive more catchment and nature-based solutions and drive innovation in river basin management.

Environmental objectives

Anglian Water agrees with most of the objectives outlined by the plans.

However, we feel they could go further as there is a low level of ambition in the forthcoming iteration of the plan which might hold us back in delivering our ambitious <u>Get River Positive</u> pledges. In partnership with Severn Trent, we have signed up to five key commitments which form the Get River Positive plan:

- Ensure storm overflows and sewage treatment works do not harm rivers
- Create more opportunities for everyone to enjoy our region's rivers
- Support others to improve and care for rivers
- Enhance our rivers and create new habitats so wildlife can thrive
- Be open and transparent about our performance and our plans

We would therefore like to see the objectives go further and enable Get River Positive to deliver to its full potential. We would like to see the objectives in the RBMP urge government to tackle all sources of river pollution, including agricultural and highways, as was clearly outlined in Water UK's 21st Century Rivers Report. The RBMP states that "to achieve the environmental objectives in the plan, the whole of society needs to play its part" so we would like a more detailed description of how the responsibility on wider society be communicated and realised.

Additionally, 18 of 672 surface water bodies are predicted to be "Good" by 2027, with a further 316 as "Good" but with low confidence, so we would like to see government put in place the policies to increase certainty of outcome on many more waterbodies.

Anglian Water does not have anything specifically to add at this time, but plans might want to consider the growing amount of private investment that can help achieve some of the RBMP objectives. For example, Landscape Enterprise Networks, which enables Anglian Water and other private businesses to invest in sustainable land management which will benefit waterbodies.

It is clear that in our region, the water and agriculture sectors are the dominant factors for many water bodies not being in good condition, even in catchments where pollution from wastewater is not highlighted as a challenge by local stakeholders.

Through the WINEP and wider water company activity, we will seek to deliver our obligations and commitments in a collaborative way where possible, using nature and catchment-based solutions where these are overall the best approach. Activities such as working with farmers, treatment wetlands and river restoration might take place across any of the management catchments in our region. Where it does, we will seek to deliver wider outcomes for the environment and society, working with catchment partnerships.
