## **FREE LISTING ON THE WATERSAFE WEBSITE**

In October 2013, the 7 Approved Contractor Schemes in the UK joined forces and WaterSafe was launched. WaterSafe is a dedicated online search facility for Approved Plumbers, and is the place where Water Companies send their customers who are looking for a plumber.

### **What about Sectored Contractors?**

- The Water Industry Approved Contractor Schemes, including APLUS, also recognise Sectored Contractors as Approved Contractors for limited scope works – that is the installation of external supply pipes.

### **Can Sectored Contractors be members of WaterSafe?**

- Unfortunately not, as membership of WaterSafe is only open to approved plumbers.

### **Can Sectored Contractors be listed on WaterSafe?**

- In order to reduce confusion and help consumers, WaterSafe will list Sectored Contractors in a separate search facility on the WaterSafe website from early 2017. This will mean that Water Companies can direct their customers to one place – WaterSafe – in order to find the right Approved Contractor for the job.

### **Can Sectored Contractors use the WaterSafe logo?**

- No. As a Sectored Contractors you will not be a member of WaterSafe so you cannot use the branding. It's a bit like being listed on the WRAS website – that doesn't make you "WRAS approved" or entitle you to use the WRAS logo.

### **Why be listed on WaterSafe?**

- Firstly it's a free benefit of your APLUS membership. Secondly, moving forward all Water Company customers will be directed to WaterSafe to find the right Approved Contractor for the job.
